Please submit to NREL a price proposal for providing all Labor, Materials and Equipment necessary to complete the following work. Include in your proposal a detailed cost breakdown. The proposal shall be valid from 60 days of date of receipt by NREL. The work proposed shall be performed under the Terms and Conditions included in the original Agreement.

In addition to the price proposal, please submit a cover letter including a summary statement indicating acceptance of the proposed statement of work or any change with the reason(s). Please include a <u>technical approach</u> to the project.

The estimated period of performance is from the issuance of the 'execution date' through 180 calendar days. Period of Performance is subject to the issuance of a Notice to Proceed by the NREL Subcontract Administrator.
